Parish Council meeting held on Tuesday 22<sup>nd</sup> September 2015 at 7.30pm in Chelmarsh Parish Hall.

#### 0. Parishioners time:

Wayne Price (Manager) and Christine Bird (Residential Director) from Meadow House attending the meeting due to a complaint received from a resident. They expOlained that a new resident decided not to comply with the boundaries they set and became very upset and emotional and the Police were called for support and the situation was resolved. They disputed the number of vehicles up and down the land the speed that they are travelling and confirmed that they had talked to all staff regarding the matter. The offer to visit Severn Valley Childcare had not yet been taken up but will arrange a meeting.

A sign for the property has been erected and any details of the ownership of the land would be appreciated as they are happy to contribute to repairs to this.

They are also keen to take part in any community events and asked that any details of such events could be passed onto them.

Brochures of the work of The Keys Group were handed out.

Chairman thanked both Wayne and Christine for attending the meeting.
